Consumers Energy Company (Consumers) Submitted a Notice of Planned Participation (NOPP) for the DE Karn (Karn) Complex, NPDES Permit No. Ml0001678 on October 11, 2021, seeking to qualify as an electric generating unit that will achieve permanent cessation of coal combustion by December 31, 2028. According to 40 CFR 423.19(f)(3) Annual Progress Reports shall be submitted detailing the progress made to achieve cessation of coal. Consumers is submitting the following information to support the requirements for Karn Units 1 and 2 at the DE Karn Complex that will achieve permanent cessation of coal combustion by December 31, 2028.

Pursuant to 40 CFR 423.19(f)(4), an Annual Progress Report shall detail the completion of any interim milestones listed in the NOPP since the previous progress report, provide a narrative discussion of any completed, missed, or delayed milestones, and provide updated milestones. An updated timeline, to reflect the requirements of 40 CFR 423.19(f)(4), is included in Attachment A.

Cold & Dark ¹ Outage Specifications Finalized	11/30/2022 4/22/2022	DELAYED - IN PROGRESS	10/13/2022: Cold and Dark outage specifications were delayed in being finalized due to Consumers' Integrated Resource Planning (IRP) Case No. U-21090, regarding the closure of Karn Units 3 and 4, which burn oil and natural gas. The IRP submitted to the MPSC on June 30, 2021, proposed the closure of all Karn Units 1, 2, 3, and 4. On June 23, 2022, a final settlement was approved where Karn Units 3 and 4 were expected to remain in operation through 2030 and as such, specifications needed to be revised to reflect this change. The delay in these final specifications will not impact Karn Units 1 and 2 retirement schedule, which are still expected to retire in 2023 consistent with the NOPP.
